Tiered Rewards System:

Depending on the value of the MXI of tokens you hold at the time of our wallet snapshots, you'll be placed into one of four tiers: Bronze, Silver, Gold, or Platinum.

Bronze (44 USD):

- Access to MXI airdrops.
- A DeFi Boost NFT.
- Option to order a crypto debit card
- DeFi access.

Silver (444 USD):

- Access to both MXI and XRP airdrops.
- A Nitro DeFi Boost NFT.
- Crypto debit card with 1% cash back rewards
- DeFi access.

Gold (4.4k USD):

- Access to both MXI and XRP airdrops.
- A Quantum DeFi Boost NFT.
- Crypto debit card with 3% cash back rewards
- DeFi access.

Platinum (44k USD):

- Access to both MXI and XRP airdrops.
- A Nirvana DeFi Boost NFT.
- Crypto debit card with 5% cash back rewards
- DeFi access.

To ensure fairness and transparency, Monerex will conduct quarterly snapshots of MXI wallet balances. This determines the tier and associated benefits each holder is eligible for in the subsequent period.
